An issue that is now with us is the fact members who pay a reduced fee under the many clubs offering them and those run by NZ Golf. After discussion it was recognised, we cannot do anything about it but following NZ Golf guidelines those such members should pay green fees when playing in any Association event. A clause in the acceptance notification letter sent to such new members be included advising them of it. Clubs to be advised but it is up to clubs how they administer that, those with Dot Golf can but those that do not have Dot Golf will in fact not know who those members are.
